- All additional designs will be charged at \$75.00 each.
- Each logo, is required to be in EPS / VECTOR FORMAT, otherwise redrawing fees will be applied.

LEAD TIME ON ORDERS

Custom jersey & sock orders: 6-8 weeks.

Confirmed ship dates are an estimate and may vary. They are quoted x-factory St. Hyacinthe.

PAYMENT TERMS: NET 30 DAYS

All sales taxes, wherever applicable, are over and above our prices and are an integral part of the sales contract: therefore, they are owed to us. Should the applicable sales tax rate change, the new rate shall be applied to all subsequent orders, without notice in accordance with the provisions of the law. All prices are subject to change without notice or obligation.

FREIGHT

All shipments are EWX from our warehouse in St. Hyacinthe, Quebec. Any changes regarding shipping instructions must be received in writing at least ten (10) business days prior to the confirmed ship date.

CANCELLATIONS

Orders cannot be cancelled or adjusted without prior authorization from SP Apparel management.

HANDLING CHARGES

A surcharge of \$20.00 will be added to all orders of \$100.00 or less.

PAYMENT TERMS

To qualify for payment terms an account must be in good credit standing with SP Apparel. Delinquent, or accounts without credit history with SP Apparel, may be required to pay part, or all, of an order's value prior to the start of production or shipment depending on the circumstances. All accounts are due and payable on the dates indicated on the invoice.

Service charges will be applied on past due accounts at the rate of 1.5% per month (18% per annum). All payments will be applied firstly to accrued service charges, if any, and then to the oldest, unpaid invoices. The purchaser agrees to pay reasonable attorney's fees and disbursements and all other costs incurred in the collection of its past due accounts.

Discounts will apply only if all invoices are paid in full to Les Vêtements SP Apparel Inc. by the due dates.

Terms & Conditions

Note: New accounts and accounts in poor credit standing will be required to pay 50% of the value of the order at the time of order confirmation and the balance before the order ships.

WARRANTY

Washing Instructions - Machine wash in cold water with like colors. Only use **non-chlorine** bleach when needed. Tumble dry on low.

Color Fastness – We cannot guarantee color fastness as we cannot control the laundering methods and other conditions that our products are subjected to.

Matching shades – Every precaution is used to match shades from one dye lot to another; however, we cannot guarantee exact matching of shades. The purchaser must accept that he/she does not have any claim for any variation of shades in same or duplicate shipments.

Cresting – The fabric in these jerseys is engineered to withstand usual cresting methods with minimum shrinkage (i.e.5% to 6%). If a heat tunnel or heat transfer machine is used, the temperature **should not exceed 152° C (305° F)**. If a heat tunnel is used, the time from entrance to exit **should not exceed 2 minutes** or excessive shrinkage may occur. We will not be held responsible for excessive shrinkage in cresting. No other person is authorized to give an additional warranty in connection with the sale of Les Vêtements SP Apparel Inc. products.

CLAIMS

All claims for shortages, defects in or damages to, merchandise received and **any claim** for error in style or color must be **reported within ten (10) days of receipt of goods.**

RETURNS

Returned merchandise must have an approved return authorization number which is valid for thirty (30) days from the date issued. Corresponding return labels provided need to be applied on the outside of each box.

GENERAL

In the event that the terms contained in the customer's purchase order contradict the terms contained herein, such terms are hereby expressly rejected.

LIMITATION OF LIABILITY

We assume no liability except as expressed in the following warranties or in these terms and conditions and, in no event, will we be liable for special, indirect, incidental, or consequential damages, whether arising in contract, in tort, under any warranty or otherwise.
